



JUDGE'S TRAINING WORKSHOP ANNOUNCEMENT

The Board of Directors has approved a comprehensive upgrading of CLC Judging. One element of that program is Judge's Training Workshops. These in-depth Workshops are conducted for geographic groupings of individual CLC regions. The second of these Workshops will be conducted for the Western Regions to prepare judges for the 2016 Grand National hosted by the Las Vegas Region. ***Although conducted for the Western Regions, any CLC member is welcome to register.***

WHAT IS A JUDGE'S TRAINING WORKSHOP?

It is 6 hours of training, including classroom instruction and the actual judging of cars. **Classroom Instruction** will cover:

- New procedures adopted by the Judging Committee for 2016
- Entrant and Judge responsibilities
- Judging procedures

Practice Judging will assemble participants into 3- or 4-person judging teams to judge one car. Additionally, a new car will be used to illustrate the standard on which all future judging will be based. Once the judging is complete, each team's performance will be critiqued.

JUDGE'S RECOGNITION PROGRAM

A recognition program for judges has been established to recognize those who judge. By judging at a national CLC judged event and other judging related activities, individuals will earn points. As the points are accumulated, each individual will progress from "Judge" to "Master Senior Judge". These titles will be confirmed by the presentation of unique pins that all judges can wear testifying to their level of judging expertise. Participating in a Judge's Training Workshop will be awarded 3 or 4 points depending on the each individual's performance.
