ELECTION OF OFFICERS

DUTIES OF OFFICERS



PRESIDENT: The President shall preside over all meetings of the Board and the membership. He/she shall appoint all committee chairpersons who, in turn shall select their committee members, except the Nominating Committee, of which the President shall appoint all committee members. He/she shall decide all questions of equal division and shall have all powers, authority and duties usually accorded a President.

VICE PRESIDENT: The Vice President shall perform such duties as may be assigned to him/her by the President or the Board. In case of death or absence of the President, He/she shall perform the duties of President.

SECRETARY: The Secretary shall record and keep all minutes of the Board and the annual meetings of the members and mail them to all board members within two weeks after the meetings. The Secretary shall carry on and maintain a file of Club correspondence and shall perform such other duties as the President or the Board may direct.

MEMBERSHIP CHAIRMAN: The Membership Chairman shall actively promote membership in the Club. He/she shall keep an up-to-date roster of the names and addresses of all Club members, send membership applications upon request, process membership applications, receive dues to be turned over to the Treasurer; and he/she shall notify the Board of any Club member whose national dues have not been current for a period of six months.

TREASURER: The Treasurer shall collect funds on behalf of the club for deposit in the club's operating account, and disburse the funds of the Club as directed by the Board. He/she shall keep the region's financial records current and in order at all times and give a report of the club's finances at each regular meeting of the Board. He/she shall render a financial report to the membership at the annual meeting, and to the President and/or the Board as they direct. He/she shall perform such other duties and possess such other powers usually accorded the office of Treasurer, or as the Board may direct.

ACTIVITIES DIRECTOR: The Activities Director shall plan and coordinate activities of interest to the Club membership, and in furtherance of the purposes for which the club is founded. He/she shall present proposed activities to the Board for consideration, and shall have primary responsibility for the details of any activity undertaken by the Club, and shall perform other duties as may be assigned by the Board.

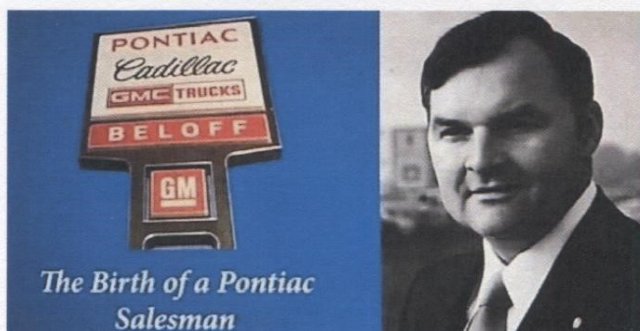

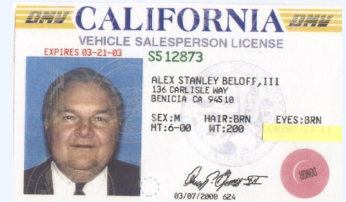
THE MECA FOR CADILLAC IS WITH YOU!

I am an original car addict who loved cars since I could crawl. At age 80, you get the benefits of a life time in the automotive field at the point of sale with the Cadillac and fine car owners. Let's hope you have not become too dignified to appreciate and respect all sister divisions and manufactures of competitive makes.

Once famously heralded as "The Standard of the World" Cadillac, the most aspirational automobile in America, could not exist without the huge styling and industrial impact of other revered Detroit manufacturers.

Back in 1990, California led the nation in consumer protection! If you sold cars, real estate, you had to be licensed. A salesperson had to have a back ground check through national crime alert. If you missed one child support payment, the state pulled your license so no dead beats!



My 1983 Cadillac Fleetwood Brougham easily made it from Columbia, South Carolina to California. I was hired as an account executive for Prestige Products Vogue Tyres for restyling Cadillacs. Note VOGUE 7 plates along with new roadster wheels and Vogue tyres.



My brother Randy Beloff lived in Orange CA near Angel Stadium. He said, *Sandy* (my nickname growing up), *I'm taking you to the best burger place on the planet!* It was the very first "IN-N-OUT". That chopped Chevy coupe was later featured on custom magazine front pages. Note the red 1959 Cadillac at the L.A. Petersen Museum. Also the almost twin 1956 Chevy convertibles among thousands of other cars at 7:30 AM as it was too hot later in the day.



I finally made the 405 mile trip to my new home in Walnut Creek (San Francisco). Saw this musical Volkswagen crossing the Oakland Bay Bridge. Must have been a Grateful Dead Group of Jerry Garcia dead-heads.

The 1954 chopped top Cadillac Coupe is the creation of John D'Agostino fame. Note the 1957 chopped Buick in Pleasanton, California.



The 1962 Lincoln Continental 4 door convertible was in exquisite flawless condition at Lafayette, CA. All the relays worked perfectly to put the top down.



Look very closely at the only 1956 Lincoln Continental Mark Coupe custom "no top" I've ever seen. Magnificent workmanship. Alameda County Fairgrounds.



This 1961 Cadillac Coupe DeVille displayed at the high school football field in Benicia, CA is as close to heart stopping perfect as it can be and far better than factory.



The 1959 Corvette in the very active Corvette stable of fine vets is stunning. Everyone was very cordial. Saw one of the worlds finest collections of 1957 Thunderbirds.



This Cadillac Coupe was a show stopper at Pleasanton, CA meet. POCI Lone Star Chapter President Tom Bracket just informed me that an almost twin went through Pebble Beach Concourse for \$200,000. A bargain for sure.





1957 Cadillac Brougham, Lafayette CA. This is one of the rarest anywhere. The Brougham was a true pillarless 4 door hard top with stub pillars for perfect suicide doors and stainless steel roof. At \$13,074, it was twice the price of an Eldorado so it was the most expensive sold in America. Cadillac lost \$10,000 per car. Note: See my alexbeloff3.com (159 cars) as I owned a 1957 Brougham bought new by the Onassis family.



This fine yellow Cadillac convertible is proudly displayed by members of the CLC of Northern Bay Area San Francisco. I became a faithful admirer and good friend to Carl Steig, chief judge with distinction for 29 years for CLC. This is a good time to encourage all to support William C. "Bill" Anderson for his Cadillac museum efforts so we may protect our legacy for future generations.

The Pate Swap Meet GP, Inc. currently has an open positions for Treasurer of the corporation. The Pate Swap Meet is the second largest automotive swap meet in the U.S.

The position is open to elections annually per Article V, Section 2(b) of the Pate Swap Meet GP, Inc. By Laws 2018: The officers of the corporation shall be elected annually by the BOD at a meeting to be held in September of each year – (September 18, 2021).

The person(s) nominated 1. Can be any shareholder's member who is in good standing is eligible to be elected to electable positions at the September meeting, and 2. The board is requesting certain qualifications to be considered in the person being nominated.

Time is of the essence, return your interest as soon as you can to Bill Levy, 214 563-1033.

Treasurer: *The individual nominated for Treasurer should be someone who has experience in accounting and bookkeeping, money handling, and should be able to perform the tasks of the position with minimal supervision and limited oversight. A brief resume outlining qualifications should accompany the nomination. Note, this person should not be a club's treasurer, but a club's member's spouse could be a candidate.*

Section 9. The Treasurer shall attend all three major meetings when treasury decisions will be made and conduct the following duties:

(a) The Treasurer shall have the custody of the corporate funds and securities and shall keep full and accurate accounts of receipts and disbursements of the corporation and shall deposit all monies and other valuable effects in the name and to the credit of the corporation in such depositories as may be designated by the Board of Directors.

(b) The Treasurer shall disburse the funds of the Corporation as may be ordered by the Board of Directors, taking proper vouchers for such disbursements, and shall render to the President and Directors, at the regular meetings of the Board or whenever they may require it, an account of all his/her transactions as Treasurer and of the financial condition of the corporation. All disbursements of Funds will be by check. The Treasurer shall also perform other such duties as may be prescribed by the Board of Directors or the President.

(c) If required by the Board of Directors, the Treasurer or any assistant Treasurers shall give the corporation a bond in such form and with such surety or sureties as shall be satisfactory to the Board for the faithful performance of the duties of the office and for the restoration of the corporation, in case of death, resignation, retirement or removal from office of all books, papers, vouchers, money, and other property of whatever kind in possession or control of that officer belonging to the corporation. The corporation shall bear all costs, if any, of any bond requirement.

(d) The Treasurer shall disburse the funds of the Corporation for the reimbursement of actual and reasonable expenses of each director and / or officer of the corporation to attend the Board of Director's meetings held in February and September and any other committee meetings as so deemed by the president in order to conduct the business of the corporation. Should an individual be serving as both a Director and an Officer of the corporation, then only one reimbursement is authorized.
